Extra Services

Transfer of Gas in Storage:

Every storage Customer can transfer Gas to other storage Customers within the storage facility.

Preconditions: The storage level of the transferring party is not lower than the transferred quantity and the available Working Gas Volume of the receiving party is not lower than the transferred quantity

Please send us three originals of the duly signed "Transfer of Gas in Storage"- Contract by 15:00 hrs on the working day before the transfer shall be affected.

OMV Gas Storage GmbH provides this service free of charge until further notice.

Assignment of Capacities:

Every Customer is entitled to assign, with the prior consent of OMV Gas Storage GmbH, its storage capacities **wholly or partly** to a Third Party. Please note that capacities can only be assigned in the form (Bundled or Unbundled) as they were initially bought from OMV Gas Storage GmbH. The partial assignment of Bundled services is therefore not possible.

With coming into effect of such an assignment the rights and obligations are assigned wholly or partly to the Third Party and you are **released from your paying obligations for the assigned capacities**, which are also transferred to the Third Party. To arrange an Assignment please send the **duly signed assignment notice** to OMV Gas Storage GmbH **at the latest 5 working days** before the assignment becomes effective.

OMV Gas Storage GmbH provides this **service free of charge** until further notice.

Subletting of Capacities:

Every Customer is entitled to **sublet the contracted storage capacities partly or in total** at any time.

In the contrary to an "Assignment" where the payment obligation is also transferred to the Assignee, Subletting of capacities does **not have any influence on your payment obligation**. Furthermore Bundled Services can be split into partial services and subletted individually.

To arrange a Subletting please send us **an E-Mail containing the information regarding quantities, subletting period and receiving Balance Group** by **12:00 hrs** on the working day before the Subletting shall become effective.

OMV Gas Storage GmbH provides this **service free of charge** until further notice.



Auction of short-term capacities:

To take advantage of short-term market opportunities, OMV Gas Storage GmbH offers you **the possibility to buy short-term Injection- and Withdrawal Capacities for the OMV storage pool via auction**. Preconditions for the participation in these auctions are

- The conclusion of a framework agreement to define the rights and obligations of both contract parties as well as
- An existing storage contract at the time of the auction entered into between you and OMV Gas Storage GmbH for Injection- and/or Withdrawal Capacity. The purchase of Injection and/or Withdrawal Capacities on the secondary market also entitles you to participate in these auctions.

Auction Procedure:

Every day OMV Gas Storage GmbH checks the availability of additional Injection- and Withdrawal Capacity for the next Gas Day and **informs you about available capacities via E-Mail by 09:30 hrs**. You may submit one or several binding bids for the total capacity or parts of the available capacity (in EUR per MWh) until **15:00 hrs** (on Fridays until **13:00 hrs**). In case your **bid was successful** you will be informed **by 15:30 hrs** (respectively **13:30 hrs** on Friday).

We will do our best to accommodate any special requirements. These can be arranged with us on a customer-by-customer basis.
