General Information

Our Unbundled Services enable you to create tailor made storage services according to your needs. You can either combine the Unbundled Services Injection Rate, Withdrawal Rate and Working Gas Volume or combine Bundled and Unbundled Services. The Unbundled Service Working Gas Volume is available in steps of 1 GWh.

Service Period

The minimum Service Period for the Unbundled Service Working Gas Volume is **1 day**.

Working Gas Volume on interruptible basis

On customer request or in case of unavailability of firm capacities the Unbundled Service Working Gas Volume is also available on interruptible basis.

The Interruption procedure shall be understood as “first come – last interrupted”. The Interruption is therefore carried out in the reverse order to the date of the contract conclusion – the contract with the earlier closing date will be interrupted last. The actual total storage level and an overview of the currently booked capacities are available at <https://ocb-st.omv.com>.

As soon as the total storage level reaches 80%, OMV Gas Storage GmbH will send a reminder via e-mail to all storage customers who have interruptible Working Gas Volume contracted. As soon as the total storage level reaches 90%, OMV Gas Storage GmbH will get in contact with all customers who have interruptible Working Gas Volume contracted to discuss the further procedure.

In case the committed Withdrawal Rate does not suffice to meet the requirements of OMV Gas Storage GmbH in case of interruption, OMV Gas Storage GmbH will provide the necessary Withdrawal Rate free of charge. Alternatively customer

- can buy firm Working Gas Volume on the secondary market and inform OMV Gas Storage GmbH accordingly and/or
- organize a Title Transfer of the working gas that has to be withdrawn with another storage customer

If the customer does not comply with the proposed withdrawals OMV Gas Storage GmbH is entitled to execute Article 7.3 of the Storage GTC's.
